If you are planning to take classes in the Summer 2008 semester and wish to apply for financial aid, please complete this form and return it to the Office of Financial Aid no later than **April 11, 2008**.

To be eligible for Summer 2008 financial aid, you must:

- ❖ Be enrolled for a minimum of 6 credit hours (if you are an undergraduate student)
- ❖ Be enrolled for a minimum of 5 credit hours (if you are a graduate student)
- ❖ ***If you received an additional Unsubsidized Stafford loan due to a PLUS Denial for Fall 2007 and Spring 2008, please have your parent re-apply for the PLUS loan again in order to determine if you are still eligible for the additional Unsubsidized Stafford loan for the summer 2008.***
- ❖ Complete the Request for Summer Financial Aid 2008 (required for all students)
- ❖ Complete a **2007-2008** Free Application for Federal Student Aid (FAFSA) if you have not already done so. You may submit the application online at www.fafsa.ed.gov. [Please note: You must complete the **2008-2009** FAFSA to apply for financial aid for the 2008 fall and 2009 spring semesters. For 2008-2009 financial aid, graduate students must also submit the 2008-2009 Graduate/Post-Bac Financial Assistance Information Form available on our web site at <http://www.stetson.edu/financialaid/forms.php>]
