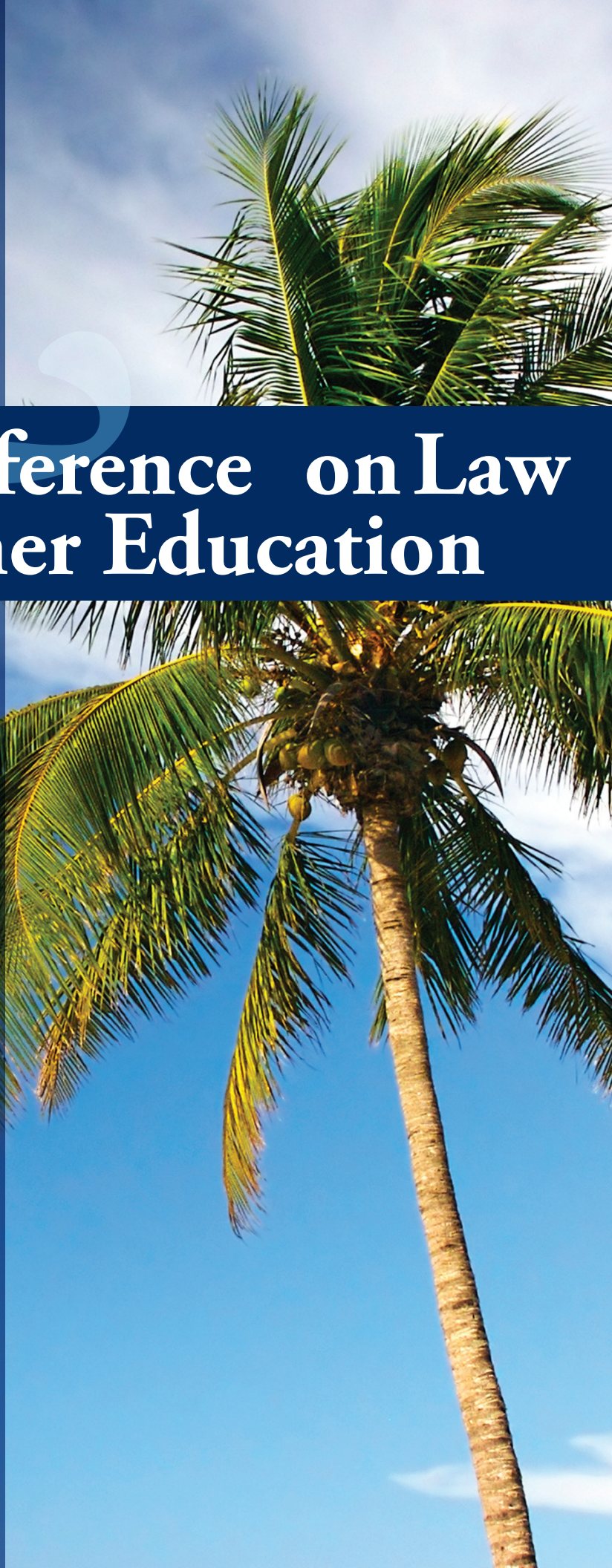

#### Title IX and the SaVe Act – Compliance, “Due Process”, Investigation and Prevention of Sexual Misconduct

*Featuring a key note address from Assistant Secretary for Civil Rights Russlynn Ali*

Preventing college sexual misconduct is now a national higher education top priority. The U.S. Department of Education has issued new guidance and ramped up its enforcement and investigation efforts. Compliance is the order of the day. Title IX compliance is legally complex; preventing and remedying sexual misconduct is difficult. This preconference workshop will be the definitive opportunity to help you assess where your campus should be focusing efforts on Title IX compliance and sexual misconduct prevention. We have assembled a team of experts to guide you in several dimensions of compliance, prevention efforts, and institutional assessment. We are especially pleased that the signatory of the April 4th *Dear Colleague Letter*, Assistant Secretary for Civil Rights Russlynn Ali, will join us as the keynote speaker for the workshop.

- Working with existing campus judicial systems
- Improving investigative training and techniques

#### The Continuing Evolution of Care and Threat Assessment Teams – Promising Practices and At-Risk Populations

This year’s post-conference workshop will feature a panel of experts on law enforcement, targeted violence research, counseling, and law who will address current issues in the rapidly developing fields of threat assessment and management, evolving practices of threat assessment and Student At-Risk Response teams, and recent trends in student suicide. The examination of threat assessment and management and response teams will include discussions on the latest targeted violence research, the evolution of legal and professional standards of care, recent trends in suicide and violence, recent state legislative initiatives, and new community based intervention strategies, inter alia. The discussion on suicide trends will provide the most recent data on student suicide and focus on specific high risk populations such as GLBT students, returning veterans, and others. Participants should be prepared to not just learn about promising practices and research, but to also work corroboratively with the presenters to help develop new practices for safer campus communities.

## About Our Keynote Speaker

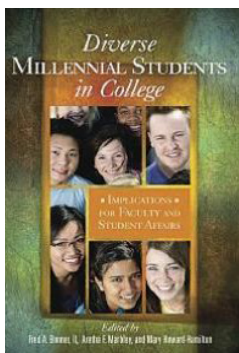


### Fred Bonner II

Fred A. Bonner II is professor of Higher Education Administration in the Educational Administration and Human Resource Development Department and associate dean of Faculties at Texas A&M University. He has published articles and book chapters on academically gifted African American male college students, teaching in the multicultural college classroom, diversity issues in student affairs, and success factors

influencing the retention of students of color in higher education. Currently Bonner serves as an assistant editor for the *National Association of Student Affairs Professionals Journal*, and has completed three summers as a research fellow with the Yale University Psychology Department (PACE Center), focusing on issues that impact academically gifted African American male college students, and spent the 2005-2006 academic year as an American Council on Education (ACE) Fellow in the Office of the President at Old Dominion University in Norfolk, Va. Bonner's most recent book, *Diverse Millennial Students in College: Implications for Faculty and Student Affairs*, was released in late 2011 by Stylus Publications.

### About *Diverse Millennial Students in College*



While many institutions have developed policies to address the myriad needs of Millennial college students and their parents, inherent in many of these initiatives is the underlying assumption that this student population is a homogeneous group. This book is significant because it addresses and explores the characteristics and experiences of Millennials from an array of perspectives, taking into account not only racial and ethnic identity but also cultural background, sexual orientation, and socioeconomic status differences—all factors contributing to how these students interface with academe.
