Move positions students to obtain CFA designation

DELAND, Fla., March 1, 2018 — Stetson University was recently welcomed into the CFA Institute University Affiliation Program. The [School of Business Administration's](#) finance program has been acknowledged as incorporating at least 70 percent of the CFA Program Candidate Body of Knowledge (CBOK) and placing emphasis on the CFA Institute Code of Ethics and Standards of Practice within the program. The Investments concentration positions students to obtain the Chartered Financial Analyst® designation, which has become the most respected and recognized investment credential in the world.
