## GAME DAY HOSPITALITY



Football season ticket holders who designate their Hatter Athletic Fund gift to football at the Champion level enjoy reserved parking in Lot 4 and entry into The Hatter Zone. Located in the north end zone of Spec Martin Stadium, The Hatter Zone includes food, soft drinks, beer and wine. Opening one hour prior to kickoff, The Hatter Zone remains open until the conclusion of the game.



Men's and women's basketball season ticket holders who designate their Hatter Athletic Fund gift to basketball at the All-American level enjoy reserved parking in Lot 1 and access to the Hall of Fame room pre-game for designated games. Located on the second floor of the Edmunds Center overlooking Wilkes Court, the Hall of Fame Room includes food and soft drinks. The Hall of Fame room is open an hour before game time until tip-off for designated games.
