## Demographics of Participating Institutions

One hundred fifty seven postsecondary institutions self-selected to participate in the Spring 2012 ACHA National College Health Assessment and 98,050 surveys were completed by students on these campuses. For the purpose of forming the Reference Group, only institutions located in the United States that surveyed all students or used a random sampling technique are included in the analysis, yielding a final data set consisting of 90,666 students and 141 schools.
