ECC is made up of 23 Licensed or license, eligible therapists, a psychiatrist, and psychiatric nurse practitioner. We meet with clients ages three and up for family, couples, and individual counseling. We seek masters level students who have completed or nearly completed their coursework and are on track to be eligible for licensure in the State of Florida. Prospective Interns are interviewed twice a year in the spring (for Summer and Fall semester start) and November (for Spring semester start). It is our preference to work with Interns for a full year from their start date. Interested students are expected to learn the administrative side of the counseling business by working our front desk. This allows them to have hands on experience with an Electronic Health Record (EHR) and learn the full client experience. It is expected that students shadow at least two of our staff therapists for an initial assessment and a family, couple, and individual session before meeting with a client on their own. We expect student interns to participate in the activities of ECC quarterly staff meetings, weekly case staffing meetings, outreach events in the community, and holiday parties as they are able. Student interns are expected to schedule weekly supervision sessions with the clinical director at a mutually agreed upon time. Interested students should submit current resume, a copy of their liability insurance face sheet and a letter of interest that includes the following:

- Their personal goals for their practicum and internship experience
