## NOTES FROM THE CHAIR

It's a wrap! Another year fades and we thankfully embrace the prospects of summer's serenity. This year's scheduled Lawson lecturer, Professor Samuel P. Huntington of Harvard, had to cancel due to ill health. We do impart our best wishes for his speedy recovery. The Lawson Committee shared ideas on future speakers during a lovely dinner at the Lake Beresford Yacht Club in February and plan two lectures in the upcoming year, one in the fall and one in the early spring semester (see details below). Proudly, I announce the awarding of two Lawson scholarships since last spring, one to Philosophy major Joe Qualls in 2005 and the other to first year student Ryan Napier. Our graduating majors were, indeed, a gifted group with the potential to become our nation's next movers and shakers. In November, Prof. Markle and I enjoyed a successful outing with students to the Florida Philosophical Association's annual meeting in Cocoa Beach. We bid farewell to Gwynn this summer as he heads west and congratulate him on his upcoming marriage and wish him well in his new position at Cal State University. Our national search for a tenure track Assistant Professor in 2006 was unfulfilled and so we reopen it this fall with renewed confidence. We will welcome Richard Glatz, who joins our department as Visiting Assistant Professor in 2006-07. He received a PhD from the University of California at Santa Barbara and specializes in metaphysics, meta-ethics, and logic. Lastly, with a heavy heart and much regret, I report the passing of Prof. R. Taylor Scott, Adjunct Professor of Philosophy at Stetson University in 2003 and 2005. Taylor died at his home in Palm Coast on May 5, 2006. We will miss his dynamic presence at Stetson.

## THE LAWSON LECTURES AT STETSON UNIVERSITY

### Fall Semester: Wednesday October 18, 2006, Dr. Jewel Spears Brooker

Professor of Literature, Dr. Jewel Spears Brooker, a Stetson alumna, has been at Eckerd College since 1981. She has received awards for teaching, scholarship, and campus leadership. She has held visiting professorships at Columbia University, Doshisha University (Kyoto), and Colorado School of Mines, and research appointments at Yale, Harvard, and Cambridge Universities. Dr. Brooker has written or edited seven books and published scores of essays on modern writers. She has received major fellowships from the National Endowment for the Humanities, Knight Foundation, and Pew Charitable Trust. She has lectured widely in Europe and Asia and has served as president of the South Atlantic Modern Language Association and other professional societies. In 2003, she was approved by the United States Senate for a six-year term as a member of the National Humanities Council of the National Endowment for the Humanities. The topic of her lecture will be announced later.

### Spring Semester:


Negotiations are currently underway to secure a distinguished speaker for the spring semester. Details will be announced at a later time.

**Brendan J. Rogers** (May 2006) is the Hall Award recipient for 2006. In addition to writing a thesis in which he argued that the categories of time cannot be intelligibly reduced to the categories of space, Brendan produced a video as part of his oral defense. The title of his thesis is "Time that Strikes an Emotional Cord: Emotion Being Used as an Argument for a Tense View of Time."

**Trey S. Smith** (May 2006) is a double major in Philosophy and History and the Haas Award recipient. He presented a senior thesis entitled "A Critical Look at Political Philosophy from the Student Movement to the Second Iraq War" and explored the evolution of Jurgen Habermas' political philosophy from the German Student Movements in the 1960's to the Second Iraq War. In his project, Trey highlights Habermas' shifting emphasis away from Marx and toward Kant.

**Kevin R. Hanson** (May 2006) is a Lawson scholar and a double major in Philosophy and Religious Studies. "In God Beyond Theism: An Analysis of John Shelby Spong and a New Paradigm of Christianity's God", he analyzes both the contemporary scholar John Shelby Spong and the traditional understanding of a theistic God. Through a concentration on Spong's view of a non-theistic God and the history of liberal Christianity that he builds upon, Kevin argued that theism is but one human definition of God, none of which can ever fully exhaust the meaning of God.

**Tiffany L. Porter** (May 2006) graduates with a major in Philosophy and presented a senior project entitled "Woman as Life: An Essay in Nietzschean Hermeneutics" where in opposition to the charge of misogyny (hatred of women), she claims that Nietzsche's emphasis on awakening the Dionysian spirit in us suggests his own positive evaluation of women.

**Rebecca L. Nichols** (May 2006) graduates with a major in Philosophy and presented a senior thesis on Aristotle's and Nussbaum's accounts of who is capable of leading flourishing lives. Her thesis, "Born Losers: A Criticism of Aristotle's Elitism" examines the question of whom, if anyone, is responsible for providing citizens with the basic necessities essential for human flourishing.

## THE STETSON UNIVERSITY PHILOSOPHY CLUB

The Philosophy Club continues to grow with more students in 2005-06 than ever before! Many thanks to our ambitious President, Greg Nolan, for reaching out to students eager to uncover the many layers of philosophical study and discussion. Club members meet in the casual surroundings of their professor's home for discussion and a student convener sets the agenda and distributes texts for conversation. There are usually six meetings a year and a new president is elected annually. It's unanimous! Next year's president will be Chantel Wonder.

The Club explored diverse topics of interest this year with discussions on Eugenics in a Liberal Democratic Society, Philosophical Theology, Wisdom, World Politics, and the doctrines of Just War and Justice in War—but none so powerful as the April screening of the underground film documentary *Winter Soldier*. The film documents the stories of the soldiers who witnessed the My Lai massacre of civilians. Scott Camil, one of the men who testified at the hearing and who played a key role in the film engaged the audience about his experience in Vietnam and how he, along with John Kerry and others, protested the war. Not only was this a brilliant example of documentary art but it also raised important questions relevant to our present war in Iraq.

## THE HALL AWARD

The Ronald L. and Margaret Smith Hall Philosophy Award was established in 2001 by Prof. Ron Hall and his wife Maggi to honor and recognize the most outstanding graduating senior in the Department of Philosophy.
