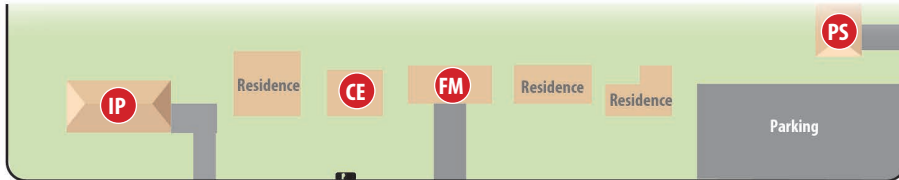
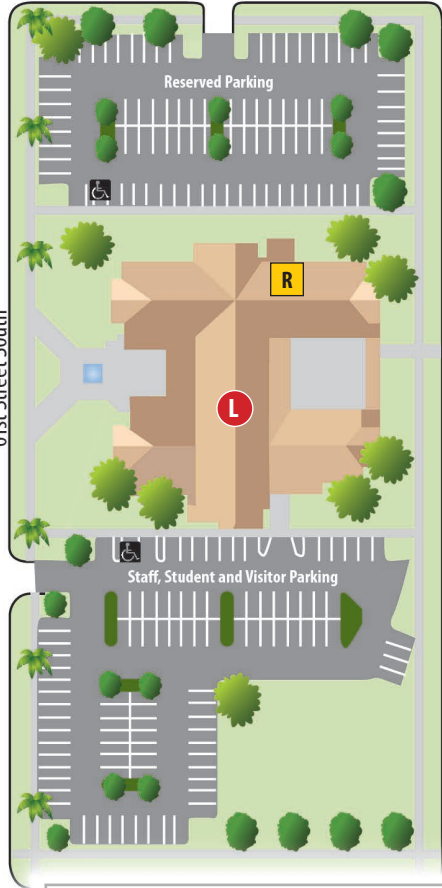
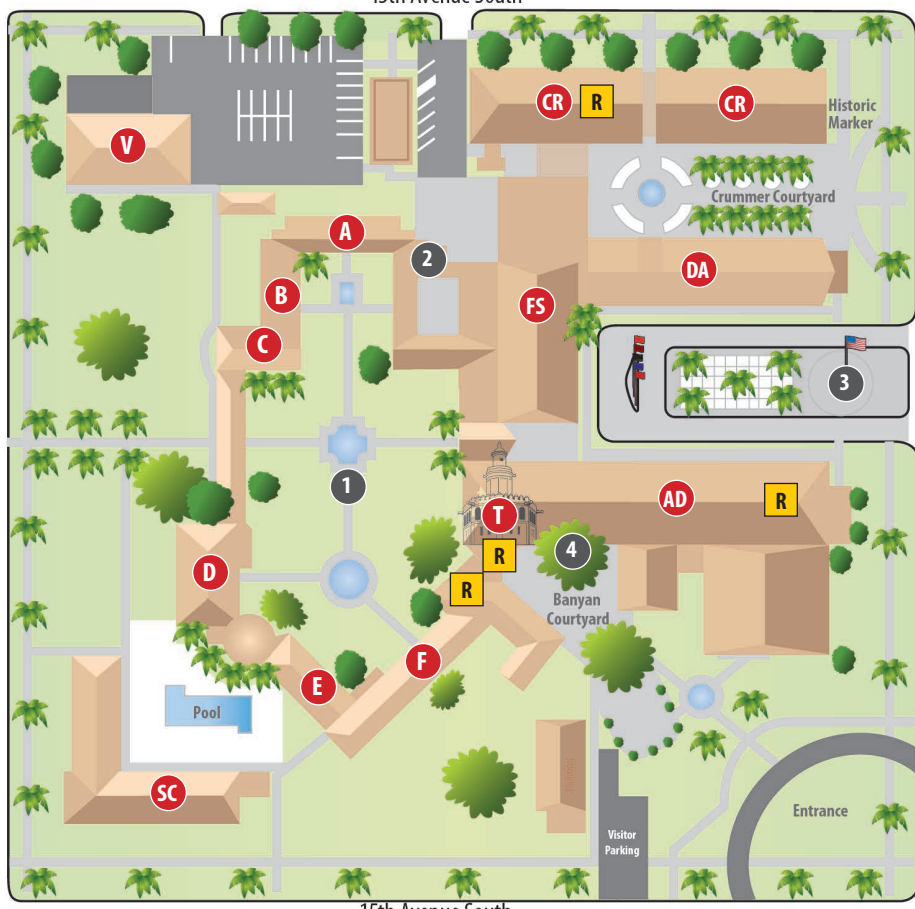


Stetson University College of Law Campus Map
