


Part-time Program Underway

of Law will offer a four-year evening program for aspiring lawyers.

The deadline is February 15, 2002 to apply for the charter class, which begins in Fall 2002 on the Gulfport/St. Petersburg campus. A new

facility in Tampa, where students will be able to complete some of their required courses, is expected to be open by Fall 2003.



Stetson has submitted a bid to buy the former Tampa Police Department property in downtown Tampa, with plans to demolish the old building and build a new facility there.

Three information sessions last year attracted significant interest in the program, said **Jan Majewski**, Assistant Dean for the new program, estimating that the school will enroll fewer than 100 students for the charter class.
