- •22 million adults 55+ in U.S.

- •Third Party Supplemental Needs Trust
- •Sole Benefit Trust

#### Case Study # 1 Frances & Wendy

- •Frances (89) widowed
- •Wendy (49) developmentally disabled
- FPSNT \$1.8M Frances is sole Trustee (no successor)
- Guardian is Frances (no successor)
- SSI + Medicaid
- •Estate Plan outdated (1990s)
- •Assets and Income

- Home \$500k CD & Savings Accts \$200k SSA + pension + Trustee commissions

#### Case Study # 2 Raymond & Mark

- •Raymond (72) widowed, estranged from family
   Active in their church
- •Mark (39) intellectually disabled No benefits
- No Guardianship
- •Assets and Income:
   Life insurance \$500k death benefit
   IRA \$350k
- Home \$425k (no mortgage)
   SSA benefits + Pension
- •No estate or special needs planning

- •Housing
- •Medicaid + SSI/DAC

#### Case Study # 3 Todd, Stella, & Jack

- •Todd (56) with stage 4 cancer parents deceased; only sibling in jail
- •Stella (54) only child; parents deceased
- •Jack (21) autistic
- Requires substantial support
- •Assets \$1.4M retirement, \$700k home (TBE), \$30k joint savings
- ${}^{\bullet}\text{No}$  legal documents, no financial plan, minimal family support
