- HIPPA Authorization
- Succession for Protective Arrangement

Estate Planning for Parents

- Contemporaneous to Settlement of Divorce- ensure consistency and completion
- > 1st v. 3rd Party Education of Counsel/Families
- ➤ Change of Beneficiaries on Accounts- Non-probate Assets
- Inventory of Assets
- ➤ Titling of Accounts/Assets
- Logistics of new relationships/kids
- ➤ Life Insurance- Term v. Whole Life
