SELECTED SIGNIFICANT LITIGATION

Chamu v. United States Attorney General, 23 F.4th 1325 (11th Cir. 2022)

Counsel for Petitioner, Oral Argument October 6, 2021

Challenge asserting overbreadth of the Florida definition of cocaine, relative to the federal definition of cocaine, and whether the Florida offense triggers removability as a "controlled substance as defined at section 802 of Title 21." Further challenged whether the state statutory language creates the "realistic probability" of this overbreadth and that no exemplar prosecution involving non-generic cocaine is required. Finally, distinguishes *Shular v. United States* and *Choizilme v. United States Attorney General* and argued that the lack of *mens rea* in the Florida offense dictates that the offense is non-generic and should not be basis for inadmissibility to the United States.

Further challenge to constitutionality of retroactive application of state court decision reversing elements of crime defined by earlier state supreme court precedent, *i.e.*, judicial *ex post facto*.

Bermudez-Paiz v. Garland, No. 20-2395 (2nd Cir. 2021)

Successful challenge (post-briefing, the Department of Justice moved for remand, thereby conceding the issue that was on appeal), using the "categorical approach" for analyzing criminal statutes, addressing whether New York definition of "cocaine" is broader than its federal counterpart (in that New York statute includes non-generic positional isomers excluded from the federal definition), and therefore does not trigger immigration consequences.

Successful challenge to finding of deportability relating to a conviction under Florida Statute §§ 893.13(1)(a)(2) and 893.101, specifically whether such a conviction constitutes a "drug trafficking crime" aggravated felony under *Lopez v. Gonzales* (2006), where the Florida scheme does not require the state to prove the defendant knowingly delivered a controlled substance, conduct distinctly less culpable that that enumerated in the federal Controlled Substances Act (CSA).

Gabriel Hernandez v. State of Florida, 124 So. 3d 757 (Fla. 2012) Florida Supreme Court

Counsel for Petitioner, Oral Argument

Successful challenge regarding the right of immigrant defendants to receive effective representation of counsel, invalidating the existent Florida plea colloquy as a cure for ineffective representation. Arguing 1) applicability of *Padilla v. Kentucky* (2010) to cases where defendant received standard Florida plea colloquy (that as a non-U.S. citizen, there <u>may</u> be immigration consequences of the plea), but deportation was mandatory, not optional, and client was not specifically advised of risk by counsel; 2) retroactive application of *Padilla* to other historical pleas taken in violation of 6th Amendment. Successful in overturning long-standing Third District precedent previously applied statewide, holding that the Florida plea colloquy categorically cures ineffective counsel regarding immigration consequences of guilty plea.

Maxi Sopo v. U.S. Attorney General, et al. 825 F3d 1199 (11th Cir. 2016) U.S. Court of Appeals for the Eleventh Circuit

Co-counsel for *amicus curiae* American Immigration Lawyers Association (joint author of brief)

Co-drafted and filed *amicus curiae* brief (filed in conjunction with the Southern Poverty Law Center) in successful case before the 11th Circuit, resulting in constitutional limitation on the U.S. government's ability to detain, for lengthy periods, without the opportunity for bond, immigrants under 8 U.S.C. § 1226(c), as such detention violates the constitutional due process concerns discussed in *Demore v.
