

Travel Information for the International Finals of the Twenty-Third Annual Stetson International Environmental Moot Court Competition— April 11–13, 2019

Important Dates

- **Friday, April 12, 2019:** Preliminary Rounds 2–4
- **Saturday, April 13, 2019:** Quarterfinals, Semifinals, and Championship Round
- **Saturday, April 13, 2019:** The Awards Ceremony and Closing Reception will start shortly after the conclusion of the Championship Round (approximately 3:30 p.m.) and will conclude at around 5:00 p.m.

Campus Location

Please note that Stetson University has four different campuses throughout Florida. The International Finals will take place at Stetson University College of Law’s campus in **Gulfport, Florida**. Airports

The closest major airport to the Gulfport campus is the [Tampa International Airport](#), which is serviced by most major carriers.

A much smaller, but closer, airport is the [St. Petersburg-Clearwater International Airport](#). Allegiant Air provides limited passenger service into this airport.

Ground Transportation

Due to the lack of convenient mass transit, we strongly encourage you to consider renting vehicles while in the Tampa Bay area. Our Gulfport campus is about 45 minutes from the Tampa International Airport. Having to depend upon taxi service could become costly.

[Bats Taxi](#) is located on St. Pete Beach and offers transportation between the airport and your hotel, and your hotel and campus. The phone number is +1-727-367-3702. Be sure to mention that you are in town for a Stetson event.
