Did you know that you could listen to **U.S. Supreme Court oral arguments** on-line? Go to <http://www.oyez.org/oyez/frontpage> to hear over 2,000 hours of Supreme Court audio available online and as podcasts. You will find an iCalendar for the current year that includes cases being argued and a section with recent Supreme Court news. Each case has buttons for abstract, participants, resources and audio. When you choose Participants, you get a photo of all the justices. Mouse over a justice and you will see the name, vote and role such as writing the opinion, etc.

Did you know there is a Stetson Movie Collection web site on the Law Library online database page list that lets you search our collection of movies? GULFPORT

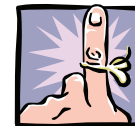
