

### What is Moot Court?

Moot Court combines the best of both worlds—persuasive written advocacy and persuasive oral advocacy! Similar to what attorneys actually do at the federal and state appellate and supreme courts, teams of two to three students write an appellate brief and prepare to present oral arguments in front of panels of judges, attorneys, and professors, at competitions, around the nation.

# What Moot Court skill did I use in my job this summer?

- ♦ While interning with the Office of Legal Counsel at the Department of Justice, I relied heavily on the research and writing skills learned during my membership on Moot Court to compose memorandums for my supervisors to utilize in their briefings with executive branch officials. Moot Court membership will teach you how to efficiently research complex legal questions while also having the ability to answer them as concisely as possible. - What moot court skill did I use this summer? Storytelling through a brief. I combed through thousands of pages of documents to construct a concise factual narrative that framed the issue on the client's side and dovetailed with the creative policy arguments. Drew Valenti, class of 2026
- ♦ I had two different opportunities this summer: The first was with the National Center for Life and Liberty, where I researched and drafted memos on First Amendment issues arising from Methodist church disaffiliation cases before the South Carolina Supreme Court and the Alabama Supreme Court. My work focused on the ecclesiastical doctrine, the use of neutral principles of law in property disputes, and the balance between the Free Exercise and Establishment Clauses—issues that required me to analyze complex precedent and frame persuasive arguments, much like in the arguments we make on Moot Court.

I also externs with a judge at Florida's Sixth District Court of Appeal, where I drafted an appellate opinion on Fourth Amendment search and seizure, observed oral arguments, and engaged in discussions on case strategy and judicial decision-making. Both experiences reinforced Moot Court skills—clear written advocacy, issue-spotting, and conversational presentation of oral arguments—while also showing me the importance of collaboration and community in the practice of law. ♦ My most used Moot Court skill at my summer associate position was legal research. In almost every task, I had to find relevant case law to the plethora of issues the partners would throw at me and then explain which cases were favorable, which were unfavorable, and why, sometimes in an email or sometimes in a motion that would be filed with the court. Because these questions were usually "urgent," Moot Court strengthened my ability to conduct extensive research quickly, meet deadlines, and provide everything the partners needed without letting anything fall through the cracks (and I am so grateful for it).
