



POSITION: VISITING ASSISTANT PROFESSOR

STETSON UNIVERSITY COLLEGE OF LAW may seek a Bruce R. Jacob Visiting Assistant Professor (VAP) for Fall 2022 through Spring 2024. The VAP program is designed for individuals seeking to enter academia by gaining full-time teaching experience and developing their scholarly agenda. The VAP will normally teach one course in the fall of their first year and a total of three courses each year. The VAP will be eligible to apply for a research grant payable during the summer between the first and second years, and will be expected to produce at least one significant piece of scholarship. VAPs receive considerable assistance and guidance in developing their academic careers including mentoring, research assistants, and support for professional travel. VAPs are fully integrated into the life of Stetson Law. Compensation is competitive with similar VAP positions; full benefits and housing are included.

Located in Florida's Tampa Bay area, the nation's nineteenth largest metro area, Stetson was established in 1900 and is Florida's oldest law school. Our main campus is in Gulfport, just outside St. Petersburg. We also have a part-time program with classes on both the main campus and our satellite campus in downtown Tampa.
