100% Online | Concentrations in Assurance/Reporting/Analytics or Tax

The accounting curriculum in the Master of Accountancy program is taught in accelerated, eight-week sessions designed to maximize your connection with the faculty and your peers, creating a vast professional network. There are no residency requirements.

All Master of Accountancy students complete a two-course core, consisting of accounting theory and cases in financial reporting, and four courses in the selected concentration. The remaining four courses are chosen from among a variety of permissible electives, including business valuation, forensic accounting and fraud examination, advanced accounting, CPA exam review, and data analytics courses, among others.

The Assurance/Reporting/Analytics concentration is comprised of four online courses, two accounting courses and two data analytics courses. The required data analytics courses are designed to meet the increasing demand from both employers and graduates to be skilled in technologies that are shaping the future of the profession. These courses include industry-relevant technologies and tools for analytics programming and machine learning.

The Tax Concentration is comprised of four online advanced tax courses, including Advanced U.S. Individual Taxation, Tax Research, Taxation of U.S. Corporations, and Taxation of U.S. Partnerships, and is designed for those with interest in a tax-related career, whether in public accounting, a business or the government.

Historically, Stetson's accounting programs have consistently outperformed others at the global, national and state levels in terms of average student passage rates on the uniform Certified Public Accountant (CPA) exam.

- Five accounting courses in the areas of Intermediate Financial Accounting I, Intermediate Financial Accounting II, Accounting Information Systems, Data Analytics (accounting-focused), and either Federal Taxation of Individuals or Federal Taxation of Entities.
